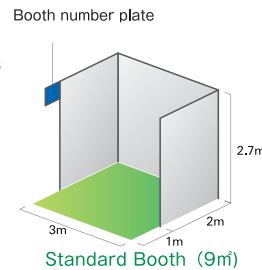


◆Booth

1) Equipment

As shown on the right, back and side panels and booth number plate will be provided.

*Carpet will be provided for all booths (The color is selectable)
*Panels will not be provided for island booths.
Panels will not be provided on aisle-sides for corner booths

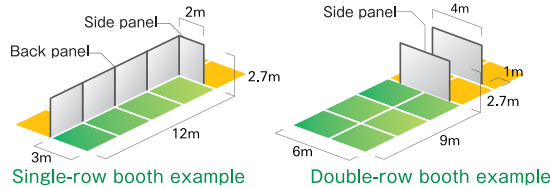


2) Layout Type

3 types are available:

- Single-row
- Double-row (Available for 4 booths or more)
- Island (Available for 12 booths or more)

*1 - 3 booths will be planned as a single-row booth.



3) Allotment

The organizer decides booth allocation taking exhibits, booth size, demonstration plans, dates of application, etc. into the consideration.

3) Withholding & Revocation

In case the organizer judges the exhibit is unsuitable for this exhibition, it may withhold or revoke the application.

Promotional Tools

1) Exhibit Space Fee

JPY 475,200 (8% Japanese consumption tax is included) / Booth
*1 unit booth = 9m² (WDH : 3m×3m×2.7m)

2) Included in Exhibit Space Fee

- ①Exhibit space, back panels, side panels, and booth number plate, carpet
- ②Invitation ticket *Quantity is determined by booth size.
- ③Operation and promotion of the exhibition by the organizer
- ④Exposure through exhibitors list on official website and handouts
- ⑤Safety management and security guard fees by the organizer

3) NOT Included in Exhibit Space Fee

- ①Decoration, construction, and operation fee of each booth

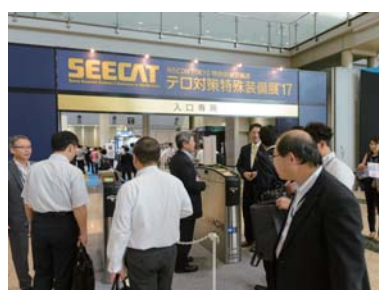
5) Cancellation

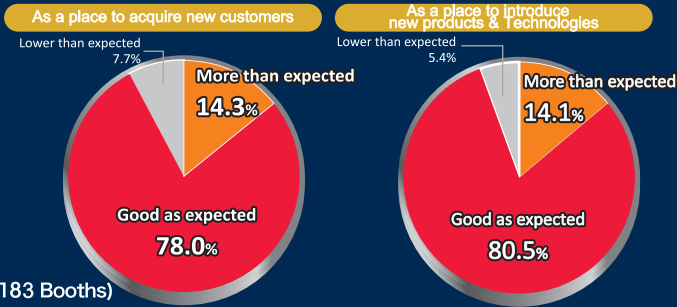

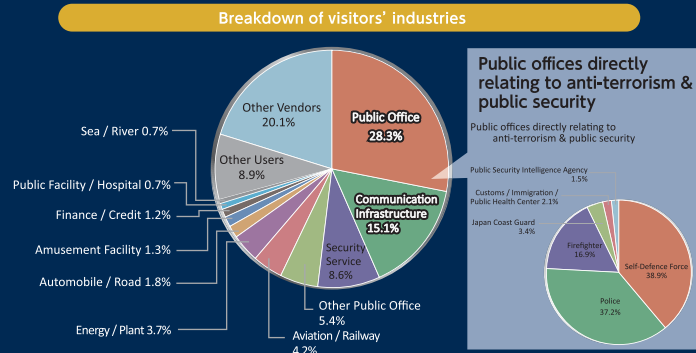

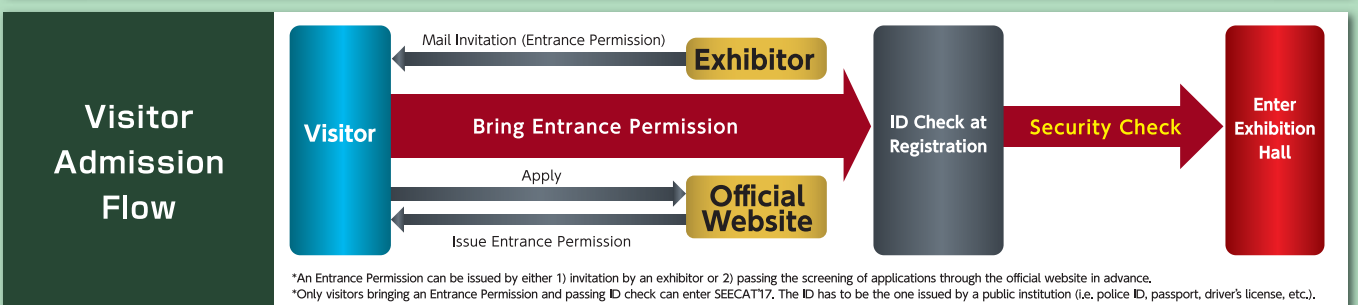
